Graceland is a humanitarian and community development organisation committed to improving the quality of life of vulnerable individuals and communities in need of rehabilitation support across Zimbabwe.

The organisation works with disadvantaged children, persons with disabilities, vulnerable families, the elderly, and people affected by drug and substance abuse, offering care, support, and rehabilitation opportunities.

Through compassionate service and sustainable development initiatives, Graceland seeks to restore dignity, create opportunities, and promote rehabilitation, self-reliance, and social inclusion among vulnerable populations. Our main focus is rehabilitation.

Legal Status

Graceland is a duly registered Private Voluntary Organisation (PVO 18/26) operating in Zimbabwe in terms of the Private Voluntary Organisations Act [Chapter 17:05].

The organisation is authorised to carry out charitable, welfare, educational, rehabilitation, healthcare, and community development activities in accordance with its approved registration objectives.

3. Our Core Programmes

Community Welfare Support: Provision of food assistance, clothing, household essentials, emergency relief, and social support to vulnerable households.

Child Protection and Care: Educational assistance, nutrition support, psychosocial care, protection services, and safe care initiatives for vulnerable and orphaned children.

Disability Support Services: Promotion of inclusion through mobility aids, assistive devices, healthcare referrals, rehabilitation support, and advocacy for persons with disabilities.

Healthcare Access and Rehabilitation: Facilitating access to medical care, rehabilitation services, and community health support programmes.

Drug and Substance Rehabilitation: Counselling support, rehabilitation referrals, psychosocial support, family reintegration, and community-based recovery programmes for individuals affected by drug and substance abuse.

Community Empowerment: Life-skills training, entrepreneurship development, vocational support, and income-generating initiatives that promote self-reliance and economic resilience.

Residential Care and Rehabilitation: Support for children's homes, elderly home units, rehabilitation centres, residential care facilities, and community health institutions serving vulnerable populations.

4. Our Impact

Graceland has contributed to positive change through food and nutritional support for vulnerable families; assistance to children and persons living with disabilities; community outreach and support programmes; support for vulnerable households facing hardship; promotion of social inclusion and human dignity; and partnerships that strengthen sustainable community development across Zimbabwe.

The organisation continues to expand its reach by collaborating with individuals, communities, government institutions, churches, and development partners to improve lives across Zimbabwe.
